Medicare Supplement Benefit Plans A, B, F, G and N

This chart show the benefits included in each of the standard Medicare Supplement plans. Every insurer must make available Plans A, B and C or F available. Some plans may not be available in your state. See Outlines of Coverage sections for details about ALL plans. **“Basic Benefits”** are:

- **Hospitalization** – Part A coinsurance plus coverage for 365 additional days after Medicare Benefits end.
- **Medical Expenses** – Part B coinsurance (generally 20% of Medicare approved amounts) or copayments for hospital outpatient services. Plans K, L, and N require insured’s to pay a portion of Part B coinsurance or copayments.
- **Blood** – First three pints of blood each year.
- **Hospice** – Part A coinsurance
- **Only Medicare Supplement Benefit Plans A, B, F, G, and N are offered by Liberty Bankers Life Insurance Company.**

Out-of-pocket expenses for this Deductible are expenses that would have ordinarily been paid by the Policy. These expenses include the Medicare Deductibles for Part A and Part B, but do not include the plans separate foreign travel emergency Deductible.
